2. Objective

- To provide timely recognition to employees who have been awarded by the Recognized External Agency at the state level and above.
- To encourage the staff and motivate them

3. Recognition received at State/National & International level in following categories:

- Best Research Paper Award in National/International Conference.
- Best Teacher/Trainer/Mentor Award.
- Recognition from other Institute/University for contribution in Conference/Seminar as a Chair/Key note Address.
- Award for achievement in Sports/culture/NCC/NSS
- Recognition received from recognized external Institute regarding contribution in Social Work/ Save Environment/ etc.
- Administrative reforms

4. Eligibility

- The faculty member (Assistant Professor, Associate Professor, Professor, Principal and Director) must be serving at any departments of Schools/ Constituent Institute/PG Research Centres or Innovation Council)
- The scheme is applicable to all regular or contractual Staff member.
- The Scheme is also applicable to all administrative staff of University.

Other Guidelines

- The application form and the proof of Achievement recognized by recognized External Agency must be submitted to IQAC-GTU along with all required attachment in the prescribed format as per **Annexure I** of every year.
- The Staff Members must have received recognition from recognized State, National or Inter National agency.
- All Staff Members are required to submit the Self-Declaration as per Annexure II.
- Multiple Application In the same category/ same achievement in different categories is not allowed except in cases of multiple patents.
- Application submitted for patent granted and such patent has joint innovators within GTU anyone is required to apply. However award money will be distributed equally among all innovators and individual certificated will be provided to all faculty member.
- University will announce this recognition on its foundation day every year.
- The decision of committee will be final and no further communication will be accepted from applicant regarding the non-acceptance of the Application.
- In case of any discrepancy the decision of Chairman IQAC, Hon'ble Vice Chancellor will be final and no further communication will be accepted from applicant.
- The university will hold its right not to award or consider any application in a year, if they are found incomplete or unsatisfactory.
