Background

Gujarat Technological University (GTU) is established in 2007 as a technological university with the objectives of developing knowledge of science, engineering, technology, management for the advancement of the quality of life of the mankind by creating centers and institutions of excellence in the above mentioned academic domains.

GTU is a State University with More than 420 affiliated colleges in its fold operating across the state of Gujarat through its FIVE zones at Ahmedabad, Gandhinagar, Vallabh Vidyanagar, Rajkot and Surat. The University caters to the fields of Engineering, Architecture, Management, Pharmacy and Computer Science. The University has about 4,00,000 students enrolled in a large number of Diploma, Under Graduate, Post Graduate programs along with the robust Doctoral program. "विशेषज्ञ -VISHESHAGYA" – A Mentor for Accreditation

1. Objective of the Scheme:

- To provide Mentoring support to affiliated institutes by Empanelling Senior Academician i.e. Visheshagya (Mentor) who will help the institute to apply for NBA/ NACC Accreditation process.
- To make maximum programmes of affiliated technical institutes accredited in the next few years.

2. Eligibility Criteria for Institute to participate in this scheme

- The Institute must run AICTE Approved Program for more than 5 years in continuous.
- The Institute must be affiliated with GTU for more than 5 years in continuous.
- The Institute must have successfully fulfil the basic prequalification for NAAC/NBA accreditation
- At least three batch of the programme must be passed out from the institute.
- Institute must have Faculty members as per AICTE & GTU norms and has full time Director/Principal endorsed by GTU for last three years.
- Institute should have a student enrolment of 50% or more in the latest Academic Year compare to AICTE approved intake.
- The admission will be considered for the program for which institute want to go for the accreditation in the near future.
- At least one program of the Institution is eligible to apply for the NBA/NAAC as per guidelines of respective accreditation agencies.

3. Role of GTU

- Gujarat Technological University will provide all kind of Intellectual support to the Mentee Institute and Mentor (Visheshagya).
- GTU will empanel/allocate senior academician as a Mentor and allocate the institute so
 jointly institute and mentor may work in coordination for getting the institute
 Accreditation.
- GTU will provide a letter to Mentee Institute regarding emplaned Mentor and Connect the Institute with the Mentor.
- The allocated Mentor will continue by the GTU after the recommendations of Mentor by filling up the (Annexure IV)
- University will pay an honorarium of Rs. 3,000/- per visit/interaction to Mentor appointed from institute of National level and Rs. 2,000/ per visit/interaction to Mentor appointed from other Institutes/Universities. The TA/DA will be also paid on the physical visit of the mentor to institute. The University will provide honorarium and TA/DA for visit/interaction once in the Quarter i.e. maximum 4 times per year.



4. Responsibility of Mentee Institute

- Gujarat Technological University will provide all kind of Intellectual support to the Mentee Institute and Mentor (Visheshagya).
- GTU will empanel/allocate senior academician as a Mentor and allocate the institute so jointly institute and mentor may work in coordination for getting the institute Accreditation.
- GTU will provide a letter to Mentee Institute regarding emplaned Mentor and Connect the Institute with the Mentor.
- University will pay an honorarium of Rs. 3,000/- per visit/interaction to Mentor appointed from institute of National level and Rs. 2,000/ per visit/interaction to Mentor appointed from other Institutes/Universities. The TA/DA will be also paid on the physical visit of the mentor to institute. The University will provide honorarium and TA/DA for visit/interaction once in the Quarter i.e. maximum 4 times per year.

5. Role of Mentor (Visheshagya)

- Under this scheme Mentors are identified and empanelled by University based on the various criteria.
- These Mentors can be serving or superannuated, willing and motivated teachers having good knowledge of the process of accreditation and can devote adequate time to make required visits to guide the Institutions.
- The mentors are thus expected to work closely with the institute and its management such that they are able to achieve the accreditation within next 12-18 months of the institute being mapped.
- Mentor (Visheshagya) should have time to visit institute. The maximum number of visit
 per Mentor per year can be four. They will be paid honorarium as per point no.3 of
 this documents. For extra visit/interaction the institute will pay the honorarium and
 TA/DA.

6. Eligibility Criteria to be a Mentor.

- Must be a Ph. D.
- Total Experience of 15 years out of which minimum 5 years in Academics.
- Worked as a program coordinator/Institute NBA/NAAC Coordinator and program received accreditation.
- Successfully received accreditation of at least one program during the tenure of his/her period while serving as a principal/Director of the Institute.
- Designation should be professor or not less than associate professor.
- Persons from the industry with a passion for education and who are NBA/NACC team members.
